FNC SUBCONTRACTS WITH EIGHT OTHER NEIGHBORHOOD BASED NONPROFIT ORGANIZATIONS TO PROVIDE AND COORDINATE PROGRAMMING. SUBCONTRACTS RANGE FROM \$40,000 TO \$60,000 PER AGENCY. THE FNC STAFF TRAINED 397 PROFESSIONALS ACROSS THE COMMONWEALTH IN PROGRAM DEVELOPMENT AND FACILITATION.
